Ms. Campbell advised the School Board that everything is working out well with our student. They have a good working relationship with The Stratton School and the transportation. RSU #78 presently has 200 kids total, with 90 at the elementary level.

RSU #78 has one teacher per grade, and their specials include Art, PE, Music, as well as a full student services team, a full time Nurse, guidance counselor, social worker, therapist, and behavior therapist. They have several new teachers this year and are fully staffed now. They are down one bus driver. Ms. Campbell advised the school board that a new Child Development Center being built on their campus, running ages 0-4 children, for 60 kids. It is scheduled to open August 2025

Mr. Laliberte spoke and advised the School Board, they presently have 39 middle school students, 55 at high school students, and they run a Ski Tuesday program in which the K-8 students get a \$50 rental pass and ski rental.
